- Applications without post dated payment will not be considered.
- NSF Fee of \$ 45.00 will be charged for any Cheque returned
- Vendors are encouraged to have their own business insurance above the market policy.
- Vendors must list on the Application ALL Items for sale before being permitted to bring them to the INNISFIL FARMERS MARKET.
- Full Season Vendors will agree to a minimum of 3 hours volunteer service to keep fees low. This can include set up/ take down of market tent/tables or help with events.
- Parking spaces are for one vehicle only behind your tent, per 10x10 space and are subject to availability. You may not have parking with your space.

## **Market Rules and Regulations:**

- I agree that the information provided is true and accurate.
- My business is producing our own products with a maximum of 30% brought in.
- If I miss two dates without prior approval, or if I am late to market twice, I understand my application will be voided without refund.
- I will be on site no later than 30 minutes prior to market start time
- I have obtained all applicable permits/ licenses/ certificates for the sale of my product
- I shall indemnify and hold-harmless, the Innisfil Farmers Market, and the Town of Innisfil, its members and employees from all claims, demands, losses, damages and actions that may arise.
- I shall indemnify and hold-harmless, Tanger Outlets Cookstown, and RioCan, its members and employees, from all claims, demands, losses, damages and actions that may arise.
